PRESIDENT'S REPORT

Another truly remarkable season! After the last two years of success it gives me great pleasure to present to you my President's Report for the Ainslie Football Club for season 2018.

After 3 out of 3 Men's Premierships in 2016, and 2 out of 3 in 2017, the points system and a number of players hanging up their boots I wasn't sure that we could back up again in 2018 in Men's 1st. Our start to the season wasn't great, losing the first three games in Men's 1st Grade and the first 8 in Women's 1st Grade. However for our Men's Program the rest, as they say, is history and it's mighty good to be a Tricolour.

Our on-field performances were built on unity and a relentless desire to succeed. We are always striving to make our members, supporters, volunteers and sponsors proud. This, by definition, is why we exist and the very essence of what it means to don the Red, White & Black.

We again congratulate the players and coaches for bringing our 27th Men's First Grade, 26th Men's Second Grade and our 9th Under18/19 Men's premiership flags back to Alan Ray Oval. A total of 62 premierships across 3 grades. In Men's 1st Grade that's an average of a flag every 3.37 years, not a bad return.

The following are the key successes from 2018;

- Finished season with Premierships in Men's 1st Grade & 2nd Grade for three years in a row.
- Our Men's Rising Stars won one of the most exciting Grand Finals in recent times, kicking the winning goal after the siren.
- Our 1st Grade Women's made the semi-finals as did our 3rd Grade Men's.
- A bright future in our juniors;
 - (i) U17's losing the Major Semi-final to eventual Premiers Tuggeranong;
 - (ii) U15's losing the Preliminary Final to Eastlake.
 - (iii) U14's were successful in their Grand Final, beating Queanbeyan in another tight contest.
 - (iv) U15's Girls fielded 2 teams, one losing the Grand Final and the other going down in Preliminary Final.
- Our efforts in the Women's Football space were no less significant as we fielded 2 women's sides for the first time. While our on field results were mixed the growth of Women's Football at our club is wonderful to watch.
- Another successful Ainslie Business Lunch with special guest and Richmond legend Matthew "Richo" Richardson
- Continued positive growth in our social media presence by maintaining, developing and promoting the AFC brand
- Another successful Volunteers Recognition Evening
- The extremely successful "Back to Ainslie Day" which incorporated the opening of the Harry Gaylard Pavilion renovations by our Patron Barbara Marshall and the daughter of Harry Gaylard - June Trembearth.
- Our continued strong player retention and recruitment of new players, all indicating a very inclusive environment.

Whilst it is important to acknowledge our successes, we must also remember the people who made this club what it is, and continues to be. This year we lost two legends of the AFC in Administrator Lyndon Hirst and five-time premiership winning player Scott Gibson.

Lyndon was the quiet achiever and backbone of the AFC for many years. He was an active volunteer for the AFC juniors including a period on the Junior committee in the 90's. In the Seniors he held several roles including Administration, match day, property, arranging presentation nights, AGMs, Annual Reports and most importantly memorabilia. Lyndon was the keeper of knowledge at the AFC.

In 2009 Lyndon wrote a book titled "The History of the AFC Juniors", which captured the history of the AFC Juniors until that year. In 2007 he was instrumental in putting together a book - "A Capital Achievement" which was launched at the AFC 80-year celebrations. Lyndon was awarded life membership of the AFC in 2009. The AFC Memorabilia collection was named after him in 2017.

Scott "Gibbo" Gibson was a five time premiership player and played 136 Senior games. A true character of our club and our most distinctive sideline voice, Scott passed away in June, which came as a huge shock to the Ainslie Family. He was certainly a larger than life character who wore his Ainslie heart on his sleeve.

We had former team mates and coaches travel far and wide to farewell Scott and we celebrated his life in the newly refurbished Harry Gaylard Pavilion. A wonderful send-off, as Scott would have liked.

On behalf of the Ainslie Football Club we thank you for the legacies that you have left us.

Early in the year we lost Carrie Graf as a Board member due to her taking up a role at the University of Canberra that created a conflict of interest with her role on the Board. Her departure has been felt, and I thank Carrie for her contributions during her period on the Board.

But every cloud has a silver lining, and with Carrie's departure we have been fortunate to have Fiona Jolly join us. Fiona has four boys playing at the club, and brings a strong governance background, which will assist no end as we address the Governance and Management section in our Strategic Plan.

We had great pleasure at the AFC Presentation Night welcoming John Smith as Life Member No 91. John has been actively involved in the Club since 1993 and the

question isn't what John has done, but rather what John hasn't done.

John's held many portfolios and roles in both the Junior and Senior Programs, however it's also the personal touch that John and his wife Julie have provided to our playing group. They have been cooks, chefs, bar staff, crying shoulders, babysitters, resume writers, loan guarantors, financial helpers, counsellors, Canberra parents, referees, employers, business partners, bedroom providers, landlords, bailiffs, mechanics, laundromat providers.

I could go on, however I'm sure you understand the huge contribution that John and Julie have made to the fabric of this club.

And speaking of the importance of volunteers in a community football club, it gave us much pleasure to present Giles Tranter with the Club's Volunteer of the Year Award at our Presentation Night. Giles came to the Club in the under 15/16s and immediately made his mark as a committed team man, before progressing into a wildly talented under 18s team coached by Scott Gibson. From the outset, Giles adopted a leadership role.

From here, Giles progressed straight into the 2s team, and in turn the first grade in 2008 and subsequently the NEAFL in 2013. Following injury, Giles slotted in the 3rd grade side, becoming captain in 2016, operating as a de facto assistant coach for both the 3s and 4s, before officially becoming 4s coach in 2017.

Not only a true on field leader, Giles epitomises the "hand up, not out" culture of community footy at Ainslie. He's always the first in and last out for the 3s/4s training, setting up training, filling water bottles, and having a chat to anyone who might be about. His commitment on field is matched by his heavy involvement in the social events off it, and can often be found supporting other grades or umpiring the women. He lives and breathes Ainslie, and this award was a fitting tribute for someone who has been at the club for the best part of 16 years. Congrats Giles, a very deserving winner.

I think it's important to note that whilst the AFC has benefited from the support of our biggest sponsor, Ainslie Football and Social Club (AF&SC), this grant has decreased over the years, mainly due to the political landscape that has impacted clubs in general in Canberra.

There will be more changes to come on 1 July 2019 and these changes are likely to further impact us financially, so it's extremely important that we remain focused on fiscal management as we continue to strive for a 50/50 funding model (AFSC/other streams) through additional sponsorship and fundraising.

To all our sponsors, in particular our major sponsors, Wayne Rogers, Simon Paterson and the AFSC Board, Moray & Agnew, Volvo Cars Canberra, Club Lime, Home. by Holly, JS Sports, Hip Pocket Workwear and the Butcher Shop, thank you for your ongoing support.

To our staff, Simon Holt, Sharlaine O'Loughlin and of course Coach Chris Rourke and Junior President Sue-Anne McKeough – another fantastic effort in getting things done to get our seniors and juniors on the paddock each week and we continue to reap the fruits of your labour.

2018 has been another great season and the challenge now is to continue to deliver a period of sustained success.

GENERAL MANAGER'S REPORT

Any season that culminates in three Premierships can only be considered a wonderful success. Furthermore, where this constitutes three in a row for Men's 1st and 2nd Grades, it elevates success to an even higher level. But Season 2018 would prove to be a real rollercoaster ride, with sadly big lows experienced around the wonderful successes.

While each season begins with cravings for, and expectations of, success, there was some concern as to how playing with a "handicap", through the application of the Player Points Allocation (PPA) would impact our Men's 1st grade team. All Men's 1st Grade teams had their points allocation reduced from 38 points to 36 points for season 2018 (Gungahlin later increased to 40 points), but Ainslie suffered an additional two point reduction down to 34 points. This additional penalty was due to 'sustained success' (an assessment lacking definition and clarity).

Could we match the success of our past two wonderful seasons?....

- Season 2016 – Premierships in Men's 1st & 2nd Grades and Rising Stars (RS). 2nd Grade & RS going through season undefeated, 1st Grade Men's just one loss.
- Season 2017 – Back-to-Back Premierships in Men's 1st & 2nd Grade (undefeated again) and Grand Final loss to RS. Women's losing elimination final in extra-time against eventual premiers.

...You Better Believe It.

The season started with us welcoming our new Principal Sponsor, Moray & Agnew (Lawyers). John Solomon and his team have had an association with the Club for some years and it was terrific to take this to the next level. Not only do we have a sponsorship arrangement with them, but Moray & Agnew also provide highly valued and knowledgeable legal support for footy operations both on and off the field, and employ three of our players.

Moray & Agnew took over from Rolfe Volvo, our Principal Sponsor for the previous 4 years. While stepping back, Rolfe Volvo continued as one of our Major Sponsors, and we are very, very appreciative of their ongoing support. With a change of ownership of the business, we look forward to developing an even more exciting relationship with Volvo.

In addition to Moray & Agnew and Rolfe Volvo, the club is proud to have the following organisations working with us as Major Sponsors:

With the increase in our Women's Footy program, it is terrific to have Home by Holly as our major partner in

the female space. The Club fielded 7 Women's/Girl's teams with over 200 registered female players. This has been an enormous increase since 2016, growth of over 300%, and we are working hard to continue this.

Our major financial supporter continues to be the Ainslie Group. The Football Club is extremely appreciative of the support provided by the Ainslie Football & Social Club (AFSC) and particularly its chair, Wayne Rogers, and CEO, Simon Patterson. The ever increasing challenges in Club land, particularly in the gaming area, have had an enormous impact on the funding that the AFSC has been able to distribute to community groups including our Footy Club. The funding allocated to the Football Club has reduced by nearly \$500,000 over the past 4 years and hence the increased need for sponsorship and fundraising dollars. The challenges faced by the AFSC in its core business and the resultant impact on funding allocations to community organisations are to be found in all clubs in the Canberra region. It is reassuring to know that, while there are challenges ahead, the AFSC is in very good hands.

In addition to our Major Sponsors we are so appreciative of the support of our 37 Other Sponsors (see page 10). Each of these organisations value-add to our footy program and we are privileged to have a relationship with each and every one of them. Please make sure that if the opportunity presents itself, that you engage with our sponsors.

The early part of the season saw things tracking well, with the extension to the Harry Gaylard Pavilion completed for our first home game in Round 4. Preseason training began nicely with great numbers on the park, all ages and genders. Of particular note was the further interest in Women's Footy and the advent of a second Ainslie Women's team. And thanks to our tireless groundspeople, Alan Ray Oval (ARO) was looking sensational.

We welcomed a number of new coaches to some of our teams, but none were new to the Club. Jimmy Rice moved from the Men's 2nd Grade coaching/playing role to assistant Men's 1st Grade coach. David Thorne and Andrew Thompson took over as Men's 2nd Grade co-coaches. Mark Ackland returned to coaching the Rising Stars, having coached them in 2016. Dani Peel stepped into the new role of Women's 2nd Grade coach. Chris Rourke, Fiona Van de Made, Tommy Lemmon & Giles Tranter returned as coaches in 2018.

The Ainslie Open Day was held on Sunday February 25. Despite terrific plans, one of the wettest days of the year saw a sturdy band of helpers huddling under the roof at Johnos watching the Oval disappear under water. While the weather dampened spirits, the day went ahead for those brave enough to face the elements. And at this point our year turned bad – well, terrible.

We learned on this day that one of the most influential people at the Club over the past 2 decades, Lyndon Hirst, finally lost his long battle with cancer. The loss to the Footy Club was enormous, but of course miniscule compared with the loss to Lyndon's family – Wendy, and children Ian, Aly & Jez, their partners and children. Lyndon filled numerous roles during his long association with the Club, across both Senior and Junior programs, initially as volunteer and later as employee. There isn't a week goes past that we don't find ourselves needing to do something that we didn't previously even know needed doing – and that's because Lyndon just got on with things, never making a fuss. He just did what needed to be done – and expertly and quietly. It was a great compliment for the Club to be asked by the family to be the guard of honour at the funeral service – many thanks to all the players that took part.

The footy season finally got underway in April and it was an inauspicious start. First Round losses for all four of our Senior teams - Men's 1s, Women's 1s, Men's 2s (first since 2015) & RS. In fact, by May 5 the Senior Footy Results were not attractive

- Men's 1st Grade 0 wins 3 losses
- Women's 1st Grade 0 wins 3 losses
- Men's 2nd Grade 2 wins 1 loss
- Rising Stars 2 wins 2 losses

Amongst this gloom was a great start for our inaugural Women's 2nd Grade team. This was the first year the competition had started with 2 Grades. After an enormous effort from our Women's coach, Fiona Van de Made, her leadership team and all the players, we were able to get sufficient numbers to run two Women's teams. And after Round 3 they had 2 wins and a loss.

The Men's 3s started with 2 wins and a loss, while the Men's 4s hadn't registered a win at this stage (unfortunately a situation that wasn't to change - please refer to Giles' summary elsewhere in this Annual Report).

There is no doubt that in our Club the Senior Football teams get the major focus of attention, and while understandable, there is always a danger of disconnect if there isn't the right support from those in the Community Football environment.

The Women's 2s did a remarkable job over the course of the season. No doubt many hard lessons were learnt but the team always came out the other side. With an enormous number of new players to the sport, the organisation required to put a team on the park with appropriate roles filled was more challenging than that faced by most teams. Congratulations to all who played and supported the team – it will get easier. A sensational effort from coach Dani Peel and all her helpers.

The Club is enormously blessed by having blokes like Tommy Lemmon, Giles Tranter and Rene Chaustowski in it. They understand the role they play in the Club and it will never be under-estimated. As with the W2s, the challenge of bringing together really good footballers who have chosen a more social footy option (social not soft) with those that are giving footy a go for the first time is a tough gig. Then there is the test of dealing with our

Senior teams when they need to take/give players at short notice. To achieve this in such a positive manner takes people who understand the big picture of the Club and, as mentioned, we are very fortunate. Thanks to all of these guys and their many and varied helpers.

By early June things had started to right themselves. We had our RSM Business Lunch with guest speaker Matthew "Richo" Richardson. We greatly value the terrific support provided by Ged Stenhouse and his team at RSM to the event, and we look forward to extending this relationship in the years ahead. To say that our guest speaker "Richo" was fantastic during his visit is doing him a disservice. The lunch was sold out (over 300 guests attended), the talk was terrific, and his interaction with guests was simply brilliant. Richo also hosted an intimate dinner the night before. The high calibre speakers we have had, the set up of the room and the high quality of food/drink at this event makes it the best Footy Lunch on the calendar. An enormous thanks to all at AFSC for their significant contribution, especially Andrew, Chris & Leanne.

By Round 5 our Women's 1s were still to register a win (this would change soon) but the Men's 1s were on a winning streak that would continue to the end of the season, the Men's 2s were continuing their winning ways and the Rising Stars were finding life a little easier now that the draw included teams other than top of the table Queanbeyan (having played them 3 times in first 6 games).

And then the second major off field loss for the year, with the sudden death on June 15 of Scott Gibson, one of the most distinctive characters and voices on both sides of the boundary. Another integral supporter of the Club whose life was taken way too early. Our thoughts remain with Corazon and her young family. "Gibbo" was a terrific club person as player, coach and spectator and his influence is missed and won't be forgotten. With relatively small crowds at local footy games the discerning commentary provided by "Gibbo" was always noticed, and, alas, is noticed more so by its absence. Those involved in organizing and helping out at the wake, held at the Pavilion, are to be thanked. These are the times that show why "Community" is so important.

Mid June saw us host Eastlake at ARO for our "Back to Ainslie" Day. This is an important day on the Club's calendar, and despite the freezing weather, we successfully brought current and past players together, and in particular, welcomed our Juniors to come and support Senior Football. On this particular occasion we also saw the official opening of the extension of the Harry Gaylard Pavilion. The opening was made particularly memorable as Harry Gaylard's daughter, June Trembearth, joined Club Patron Barbara Marshall to "cut the ribbon". There are so many to thank for this project but I will just mention a few: Empire Homes (Ian Lawless); Mitch Ward; John O'Loughlin; Andrew Toy; Michael Richardson and Brett Hannam. The improvement to the Pavilion, through increased gym space, much improved toilet/shower facilities and a multi-purpose Memorabilia room, is highly valued by all who use them. During the season, and since, we have seen an increased use of the gym, a terrific endorsement of the project.

An area where we didn't have the success we had hoped for was in the Social Events space. A couple of "all of Club" events were terrific - the cocktail night after the first game of the year and an 80s night in July - but the events weren't communicated as well as we would have liked, and there were less events than we had intended. The planning is already in place to improve this. It's pretty hard to get buy in on each occasion from all seven senior teams, and so we will move to offer a limited number of events with a targeted outcome.

Part way through the season our beloved Head Coach had an enforced holiday. During our fifth game of the season, when things weren't travelling so well on field, and with our opposition topped up by nine Canberra Demons players, Chris yelled a couple of inappropriate comments from the Coaches' Box. The Board assessed that Chris' behaviour was outside Club Values that we live by, and Chris was issued with a one match Club suspension.

Chris missed the key game against Belconnen, and of note, this was an enormously important game under the coaching leadership of Jim Rice. Chris' address to the players and coaching team on the Thursday prior to the game was outstanding. Those who know Chris realise that he is a very passionate Coach and incredibly protective of his players and his Club. His ability to turn this negative situation into a positive learning experience is to be admired. Recognise what happened, accept the consequences, identify how this can be utilised, and renew the aspiration to model the Club values. Another reason to marvel at the enigma that is Chris Rourke.

This pre-emptive action by the Board, long before AFL Canberra could or needed to get involved, displayed the integrity and maturity of our Club, and the importance we place on our Values

There are plenty of other examples of inspiring people within our Club. Each team will have a number of examples; those recognised at our Presentation Night are just some. But it would be remiss not to recognise two awards at Presentation Night. Enormous congratulations and thanks go to John Smith, the Club's newest Life Member, and Giles Tranter, the AFC Volunteer of the Year. Their contributions over many years are too long to list; suffice to say that we are heavily indebted to both these men.

A special acknowledgment to all the players that have gone above and beyond the norm this season. To all the Women's 1s players that doubled up in order to help the 2s have enough to play. Plus enormous thanks to some of our Men's 2s players that played for Tuggeranong and Gungahlin to help them field teams against our own 2s teams.

I don't need to tell you that we managed to replicate the Men's Premierships won in 2016 and 2017. I would put it to you that each year it gets harder as the other Clubs get more desperate to end our run. The victories in 2018 were sweeter because of this and each had their story.

- RS managed to beat Queanbeyan only once all season, requiring an "after the siren" goal to secure Grand Final victory,



SENIOR MENS COACH'S REPORT

After winning two premierships in a row, the challenge of a 'three peat' was there, but the task was not going to be made any easier with the loss of champion players Curtis, Barrie, Ledda and outstanding junior Jack Powell, as well the league penalising us a further four points under the point system (due to us winning the last two premierships). This meant we played at a 2 point penalty each week compared with every other side in the competition. AFL Canberra also introduced another rule stating all teams had to play at least nine local club juniors in their starting 22 players each week.

This change to the points system meant if we were to win the flag we would be the first team in ACT to win after being so handicapped!

So with all these changes and departures, training began in November and, with what has become the norm for the Ainslie Football Club, it was open to all players from all ages; so the first night back on the track saw over 90 players appear, a great way to start the season. These sessions were run by our new assistant coaches in Jim Rice and the returning Rob Tuohey and our new strength and conditioning coach Jason Fleming.

Late January saw the senior squad return and the players seemed fresh and keen as they pushed their bodies hard in what was a hot and tough pre-season. Their spirits lifted with the return of Simon Horner, Ian Lawless, Max Richardson and Nick Salter (who was keen to travel down from Sydney each week to play). As well, talented youngsters Nelson Foley and Ben Jamieson were lighting up the track. So after what seemed like a never ending pre-season, we fronted up to our arch enemy Belconnen in a Round One replay of the 2017 grand final.

This game was the start of a horrid period for the club where we managed to lose the opening three games! Questions were asked, and before we took on Tuggeranong in what was the "battle of the wooden spoon", a nervous Ainslie side had gone "back to basics" on the training track, and ran out determined to get our season back on the rails. It was far from convincing but we got the four points, and this was followed by a win over the Jets and then a season changing game against the previously unbeaten Belconnen which showed the football world that we were far from a spent force. The remainder of the season saw us not drop a game as we had players returning from injury, players who had struggled early finding form, and the hunger to succeed returned. With one round remaining we were equal top. That last game saw us demolish the Jets and with Belconnen losing, we finished on top of the ladder which gave us the advantage of playing the second semi-final on Alan Ray Oval, always a tough task for the visiting team.

The second semi-final saw us once again take on the Magpies who had lost star captain/coach James Bennett

through injury. A confident Tri-colours outfit started strongly and were never headed by a gallant Magpie side. Ainslie key forwards all looked dangerous, leading goal kicker Hayden Armstrong kicking 4 and with Captain Henry Delves returning to form, Ainslie ran out comfortable 59 point winners to go straight through to another grand final. And for the first time all season there was a real thought of us being able to achieve a 'three peat'!

As has been the case in nearly every grand final we have played in over the last 12 years, we had a trip to the tribunal and a nervous wait as co-Captain Aaron Wiles had been cited by Belconnen. Once again, with our major sponsor Moray and Agnew representing us, we managed to win the case and Wiles was free to play. Belconnen had gone out in straight sets and the young and exciting Eastlake were set to take us on; as they had beaten us previously on their home deck, they were extremely confident of winning their first flag in over a decade. The game started with champion forward Nick Salter wasting no time in hitting the scoreboard, and by the end of the first quarter he had kicked three goals and we held a handy 30 point lead. But Eastlake, playing with a "nothing to lose attitude", fought back and were only 3 goals down at the main break. The third quarter saw Ainslie again take the ascendancy, but we were still not putting the Demons to bed. The start of the last quarter saw Eastlake kick two quick goals and reduce the margin to 14 points, but that was as close as they would get as exciting teenager Ben Jamieson kicked two quick goals to continue his great game. Salter kicked another and when the siren went, the Tri-colours were 34 points ahead and the 'three peat' had been achieved.

SENIOR WOMENS COACH'S REPORT

The 2018 season was a very successful season for the senior women's team. For the first time in Ainslie history we were successfully able to field 1st grade and 2nd grade teams with over 60 female players registering for the season.

Prior to Christmas, preseason training began which included men's, rising stars and the youth girls. Putting the women's teams through their paces as well as getting to meet other members and coaches of the club was part of the process.

Post-Christmas the women's team was back at it, hitting the track in the summer heat. It was great to see the squad numbers continually growing as well as a number of youth girls also training. The team had a couple of early setbacks with several players receiving season ending injuries which was disappointing for them and the team.

Towards the end of preseason, a couple of practice matches we set up to prepare us for round 1 with some positive outcomes, leading to us believe that we would be in for another successful year in 2018.

Our believed success became a reality check when we hit Round 8 without a win on the board. The team had a couple of heartbreaking losses against the Hawks and Jets, but our expectations versus reality did not match.

To the girls credit they never gave up. No matter rain, hail or shine, both on and off the field, the girls pushed themselves to be better than the week before. The belief was in the air that we could be finalists again as long as we remained committed.

Finally, we got our first win on the board against the Hawks to whom we had earlier lost to by the smallest of margins.

The team then managed to beat the Jets the following week which gave us back to back wins and the confidence grew.

Each match the girls played they got better and better with the margins shrinking against the top teams. We now knew that in order to make finals we needed to beat the Hawks and Jets again to secure 4th position on the ladder. Both matches were do or die.

The girls secured a finals spot, finishing 4th on the ladder after a late season surge.

A strong week of training and preparation left us confident and ready to play, against club rivals, the Queanbeyan Tigers. After a four- point loss, in an extra time preliminary final last year against them, we had a lot to play for.

Again it wasn't our year, losing to Queanbeyan by 13 points. Despite losing 2 players early on in the game, the girls stood tall and fought hard for each other.

A number of individuals excelled in the 2018 season, with both Zoe Skyrianos and Marley Simmons being named in the 2018 AFL Canberra Women's team of the year. Zoe also took out Ainslie Women's Best and Fairest, followed by runners up Maddy Holloway; Dakota Hooper being player's player, and Allyson Flynn Most Improved. Teigan Hawke was named Club Person of the Year.

With 2019 fast approaching, both grades look to take it further, and use the devastation of the Preliminary final loss to take home the 2019 Trophy.


Thanks also to Mark Ackland, and the Rising Stars, who supported player movement between grades and the young men who took on the challenge of senior footy so young in their football journeys.

RISING STARS (U18s) COACH'S REPORT

2018 proved to be an up and down year in regards to the quality of football played. Our best was better than the rest, but unfortunately when we were off our game our worst wasn't too flash. This resulted in a 10 win 6 loss season and finishing third on the ladder at the end of the home and away season. A surprise loss to Gungahlin Jets in round 16 as we headed for finals turned out to be the turning point desperately needed. Training standards finally lifted to the level required, the boys came up with the slogan "Go at 100", recognising the link between training efforts and playing well on game day. Players also recognised that every time the ball hit the ground at training it represented a turn over during a game. The old saying "Train as you play" is so true. "Go at 100" became our slogan on our Grand Final team banner. The team finished off the season with 6 straight wins to clinch the premiership with an after the final siren shot at goal and the resultant goal saw us win by 3 points. Our best was better than the rest and we finally proved it. Fairy-Tale stuff. On a personal level, to beat the minor premiers, Queanbeyan, whose coach was named "Coach of the year" by AFL Canberra, was very satisfying. Once again Fairy-Tale stuff.

Discipline was a big part of the game plan. Crossing the white line never gives any player a right to step outside the laws of the game or the law itself. I am extremely proud of this group's discipline on match day. We proved how the game should be played - "Hard but Fair" at all times. It was an honour to coach this team.

The Under 18 competition really can be split into two totally separate competitions. Home & away and finals. The finals competition differs from the home and away season, as all clubs have their representative players available for finals; this radically changes the dynamics of all teams finishing in the top four, meaning any of these teams can realistically win the premiership. Making our victory all the sweeter was the fact that we only had one representative player, and he was available most games anyway. As a club we also did not bring any players back from higher grades.

The coaching focus in 2018 was again to let players develop by playing positions not experienced during their junior years. This helped expand each player's football resume and understanding while at the same time building a team that was very versatile and not dependant on a handful of players. Taking the focus away from representative players built confidence within each individual and the game plan. Many players, although not representative players, are still exceptional football talents. This is what the 2018 Ainslie Under 18 Rising Stars' success was based upon, although I was questioned many times. I remember Justin Foley's advice back in 2016 - Back yourself.

2018 saw a total of 38 players play for the Under 18's with 14 of these making their debut at this level after transitioning from the junior ranks. 26 players were used in the 3 finals played. Of the 38, 3 were over age and granted AFL permission to play, (only 2 played in the final series, 1 in the Grand Final), 14 played at their age level (12 played in the Grand Final), 16 were eligible for Under 17s including a GWS Academy player (11 played in the Grand Final) and 5 were eligible for Under 16s (2 GWS Academy players). Twenty one of the above players are eligible for Under 18's in 2019 making next year's list very strong indeed; we should again push deep into finals given the right environment.

I would like to thank many people for their help and advice along the way.

Senior coach - Chris Rourke was again outstanding. Chris's advice and feedback throughout the season was immensely helpful. From the sidelines he would quietly observe and supportively advise players and myself of areas of strength and weaknesses. Chris's re-appointment as senior coach is a great credit to the club, providing continued stability at the top. Chris's enthusiasm is infectious.

As well as Chris, I would like to thank General Manager Simon Holt and Greg Bishop for trusting me and appointing me Rising Stars coach in 2018. It was an honour and responsibility I took seriously.

The Ainslie Football Club Board - Thank you to all Board members for your work and dedication in providing an environment of high standards and culture. As members we are all responsible in upholding these values.

Steve Martin as team manager was brilliant; everything ran like clockwork on match days, allowing me to concentrate on the players - thanks Steve.

THIRD GRADE MENS COACH'S REPORT

Thom Lemmon's coaching reign of terror in third grade moved into its third season in 2018. A number of new faces showed up for preseason training, which was promising coming off a somewhat disappointing 2017 season. A handy win in a preseason fixture against local rivals ANU held the side in good spirits for the start of the season proper.

The season began with a tough assignment against perennial community footy powerhouse Woden, who were coming off their third consecutive grand final appearance. The boys battled manfully all day at Stirling, unfortunately going down by 5 goals. The following week saw the first home game of the year, against a much improved Googong Hogs side. After a tight opening half, the boys kicked away to grab a 7 goal win, before heading into a Friday night fixture against an Eastlake side returning to third grade for the first time in a few years. In dewy, slippery conditions, the 3s put in their best showing of the young season, touching up the Demons to the tune of 83 points.

Next up was the always difficult trip to Batemans Bay to take on the Seahawks. Despite a burst of excellent footy just before half time to pull within 4 points, the Seahawks kicked it up a notch in the second half to run away with a comfortable victory. A loss to Molonglo back at Alan Ray the following week dropped the Tricolours to 2-3 coming into a Wednesday night fixture against reigning premiers ADFFA down at Greenway Oval. After chasing a mob of kangaroos from the playing surface, the boys came out on fire to establish a 3 goal lead at the main break. From here, they never looked back as they ground their way to a 6 goal win on the back of excellent physical footy and sharp ball movement.

The win coincided with probably our best patch for the year, knocking off the difficult Coota in Coota the

following week in atrocious conditions. From here, the 3s split games against their main rivals, losing to ANU at South Oval before belting Belconnen by 83 points to hit the halfway point of the season at 5-4 and well in the finals mix.

The second half of the season once again saw the Tricolours defeat those below us on the table, with good wins over Eastlake, Belconnen, Googong and Cootamundra. However, things did not go as smoothly against the sides above, with losses again to Woden, Molonglo and Batemans Bay. ADFFA also levelled the season series with Ainslie with a ruthless victory at Ainslie in one of our worst performances for the year.

However, a week out from finals, the 3s were able to finally break through for a win at South Oval against ANU. Playing at South for the second time this year on the back of first grade finals being scheduled on the same day at Alan Ray, the 3s were bolstered by the inclusion of several regular 2s players. We opened the game incredibly strongly, opening up a 3 goal lead at half time, before ANU came hard in the second half, and we held on to win by 2 points, ultimately qualifying us in 5th position, above ANU, for finals.

Our elimination final was against ADFFA at ADFFA, where they also had both their women's side and 4s side playing finals. In a pretty tough environment, the boys gave a really good account of themselves, but ultimately came up short, the Rams kicking a couple of goals late to run out victors by 5 goals and end our season.

All in all, it was a reasonably good year. We managed to get a few new faces into the side, and with some further time together we can hopefully take it to the next level in 2019.



FOURTH GRADE MENS COACH'S REPORT

The 2018 fourth grade season was a tough slog, to put it mildly, as the side endured a winless season that was marked by injury and absence throughout. While that doesn't paint a positive picture, there were a number of silver-linings to come out of the year, not least of which was the attitude and determination of the team's core in the face of adversity. It's that sort of mindset that makes me confident that the team will bounce back next season.

From the start of the season it was clear that we would be behind the 8-ball as the depth throughout the club was tested. The higher grades' injuries and early season struggles had a ripple effect on the lower grades, which ultimately meant that fourth grade started the season without many fringe higher grade players. For those who don't know, the engine room of the Ainslie fourth grade team usually relies on fringe third grade players running through the midfield and influencing the play, interspersed with a few wily veteran mids, to compete against other teams in the competition that are stand-alone or two-team clubs and which have quite high-level talent in the guts. To put it into perspective, our round 1 starting midfield consisted of three veteran backmen who have only intermittently played midfield in their careers, and a 36 year old debutant ruckman. They were surrounded by eleven other players making their debut for the club, only a couple of whom had played football outside of juniors. It was an eye-opener for our debutants as a strong and experienced Woden side handed out a 170pt shellacking. Welcome to 2018! On a positive, veteran Will Wright was a stand-out in his second season back in footy, attacking the ball and the opposition with equal ferocity, while skipper Rene Chaustowski was a rock down back, and newcomer Eli Weston showed potential through the mids and half-forward.

Things didn't get much better from there as promising young player Tom Armstrong did his ACL in the opening minutes of round 2 in his second ever game of footy, and a number of other players pulled up lame in a 19 point loss to Googong. This continued throughout the season as players got injured for weeks and months at a time, some went on extended holidays and, as it should in the lower grades, various life events took precedence over footy on any particular weekend. In the end we had 66 players play fourth grade in 2018, 25 of whom made their senior football debuts for the Ainslie Football Club and got a lot more game time than they probably expected when they rocked up in pre-season. This was probably our biggest silver-lining, with a number of these new players becoming integral strands in the fabric of our fourth grade culture. Players like Popey, Baz, Cam, Toddy Hennessy, Benny Mac, the Quades & Dobs brought energy, enthusiasm and most importantly a passion for the football club and their teammates that helped hold the team together this year.

Other standouts this season were Will Wright who polled in 14 of our 18 games as he ran away with the Best &

Fairest; Al Bunday who was not only our runner-up B&F, but was also selfless in his team-first attitude and stood up as a leader throughout the season; our captain Rene Chaustowski who set an example on the field each and every week as he defended staunchly and then tried to create attacking drives against the tide at every opportunity (Rene also took on a fair bit of the coaching workload this year, running many of the training sessions as well as our post-match talks while I was playing 3s); Eddie Marshall had his best season in memory as he played 15 games, and finished fourth in the B&F and showed that having a good

footy brain is an invaluable asset; Miles Davis, who coached the team for me when the threes and fours were playing at different venues, thanks very much. Our other awards winners, Dan Eastman who won the Coaches Award for his development and his desire to learn and improve throughout the year; Chris Watkins as the Best Clubman for all the little things he does around the squad without asking that make mine and the rest of the team's lives easier; and our Most Consistent Player, Joey York, the unassuming back pocket who goes about his job with a minimum of fuss. And lastly to all the players that got dropped to fours towards the end of the season when the rest of the club got fit and healthy, thanks for the great attitude you had in coming back down and giving your all in fourth grade; it made it very easy for Tommy to pick you again for finals when the opportunities arose.

Looking forward, I think this was the bottom of the curve and it can only be onwards and upwards from here. With a smidgeon of luck on the injury and availability front, we will hopefully get more games out of a number of our senior players that didn't get on the park this year, our new faces will continue to stick around and develop their games to the next level, and we'll see a bit more depth early in the 2019 season which will add that touch of class to fourth grade. Congratulations to our 3 premierships teams and the efforts of both our women's teams and third grade, and see you all again in 2019.



JUNIORS REPORT

It is a pleasure to be presenting the juniors report for season 2018 in my first year as Junior President. It would be remiss of me if I did not start with a huge thank you to the previous Junior President and now General Manager, Simon Holt, for his support and assistance throughout the season. I would also like to thank all those throughout the club that have helped me settle into this role.

This year was another successful year for the Ainslie Juniors. The principal activity of the Club during the financial year was to foster the game of Australian Football.



NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 30 SEPTEMBER 2018

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements cover Ainslie Football Club incorporated as an individual parent entity, and Ainslie Football Club incorporated and controlled entities as an economic entity. Ainslie Football Club Incorporated is an association incorporated in the Australian Capital Territory under the *Associations Incorporation Act (ACT) 1991*.

a. Principles of Consolidation

A controlled entity is an entity controlled by the Ainslie Football Club Incorporated. Control exists where Ainslie Football Club Incorporated has the capacity to dominate the decision-making in relation to the financial and operating policies of another entity so that the other entity operates with Ainslie Football Club Incorporated to achieve the objectives of Ainslie Football Club Incorporated.

All inter-company balances and transactions between entities in the economic entity, including any unrealised profits or losses, have been eliminated upon consolidation. Where the controlled entity has entered or left the economic entity during the year its operating results have been included from the date control was obtained or until the date control ceased.

b. Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements and Interpretations issued by the Australian Accounting Standards Board ('AASB') and *the Associations Incorporation Act (ACT) 1991*.

Material accounting policies adopted in the preparation of these financial statements are presented within the statements and have been consistently applied unless stated otherwise. The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest dollar.

c. New or amended Accounting Standards and Interpretations adopted

The Club has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period. Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

d. Critical accounting estimates

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

i. Estimation of useful lives of assets

The Club determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

ii. Employee benefits provision

As discussed in note 14, the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

e. Comparative figures

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

f. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

g. Company limited by guarantee

In accordance with the Constitution the Club is a Company limited by guarantee and accordingly no shares have been issued and no dividends recommended or paid. Liability of each member is limited to the amount of \$2.

NOTE 4: INCOME TAX

The Committee Members estimate that the cumulative potential future income tax benefit at 30 September 2018 in respect of tax losses for the group not brought to account is \$429,839 (2017:\$379,828).

This benefit from tax losses will only be obtained if:

- (i) The club derives future assessable income of a nature and of an amount sufficient to enable the benefit from the deductions for the losses to be realised;
- (ii) The club continues to comply with the conditions for deductibility imposed by tax legislation; and
- (ii) No changes in the tax legislation adversely affect the club in realising the benefit from the deductions for the losses.

Income tax is payable on that proportion of the income less expenses contributed by non-members. The aggregate amount of income tax attributable to the financial year differs from the amount prima facie payable on the operating surplus. The difference is reconciled as follows:

Accounting Policy

The Ainslie Football and Social Club (the subsidiary) is taxed according to the principle of mutuality. The charge for current income tax expenses is based on the profit for the year adjusted for any non-assessable or disallowed items. It is calculated using tax rates that have been enacted or are substantively enacted by the Statement of Financial Position date.

Deferred tax is accounted for using the Statement of Financial Position liability method in respect of temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. No deferred income tax will be recognised from the initial recognition of an asset or liability, excluding a business combination, where there is no effect on accounting or taxable profit or loss.

Deferred tax is calculated at the tax rates that are expected to apply to the period when the asset is realised or liability is settled. Deferred tax is credited in the income statement except where it relates to items that may be credited directly to equity, in which case the deferred tax is adjusted directly against equity.

Deferred income tax assets are recognised to the extent that it is probable that future tax profits will be available against which deductible temporary differences can be utilised.

The amount of benefits brought to account or which may be realised in the future is based on the assumption that no adverse change will occur in income taxation legislation and the anticipation that the economic entity will derive sufficient future assessable income to enable the benefit to be realised and comply with the conditions of deductibility imposed by the law.

Ainslie Football Club is a sporting organisation under section 50-45 of the Income Tax Assessment Act 1997, as amended, and is exempt from paying income tax.

Accounting Policy

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation.

Property

Leasehold land and buildings are measured on the fair value basis, being the amount for which an asset could be exchanged between knowledgeable willing parties in an arm's length transaction. It is the policy of the club to have an independent valuation on a cyclical basis, with annual appraisals being made by the Directors.

Plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. The carrying amount of plant and equipment is reviewed annually by Directors to ensure it is not in excess of the recoverable amount from these assets.

An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised lease assets, but excluding freehold land, is depreciated on a straight-line basis over their useful lives to the club commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

Impairment of Assets

At each reporting date, the club reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the Statement of Comprehensive Income.
